Management systems are constantly updated and new ones are developed. Also, accreditation systems not mentioned in this list can be accredited. Through the extension of this accreditation scheme to cover other management systems, also the criteria for accreditation are complemented. In order to take on a new scope, close collaboration with the conformity assessment body and other stakeholders is ensured. In case of updating the existing standards for management systems, the transitional provisions shall be laid down by the International Accreditation Forum (IAF). If necessary, the state agency "Latvian National Accreditation Bureau" (hereinafter - LATAK) provides additional specified conditions.

II Structure of the Scope of Accreditation

There is an Application Form (F.003) available on the website of the LATAK www.latak.gov.lv, which includes information on the scope of accreditation applied for (Annex 7 to the Form). The structure of the scope of accreditation is as follows:

- Column 1: Object to be certified.
- Column 2: Technical scope, e.g., technical scopes pursuant to IAF ID1 or the scope of food safety pursuant to ISO 22003-1, etc.

Column 3: Remarks (if necessary), e.g., clarifications of the technical scope pursuant to NACE 2 rev.

Accreditation certificates of accredited management systems certification institutions, including accreditation scope, are published on the LATAK website www.latak.gov.lv.

III Documents to be submitted

Management systems certification institution shall submit to LATAK the necessary documents to **commence the accreditation process** (specified in Form F.002.S2), as indicated on the website of LATAK: www.latak.gov.lv for Management systems certification institutions, as well as duly completed forms:

- F.003 Application (including Annex 7).
- F.003.S2 Information on the management systems certification institution.

For the purposes of surveillance, after obtaining the accreditation, the management systems certification institution shall submit the following duly completed forms and the necessary documents prior to the monitoring:

- F.003 Application, including Annex 7 thereto (Scope of Accreditation), if the scope of accreditation has been amended, together with the application for narrowing down or expanding the scope;
- F.020.S2 Information on the management systems certification institution;
- Management report of the certification institution for the reporting period;
- Relevant certification schemes;
- changes made to the management system documentation (current management system manual or updated parts of it);
- list of documents of the certification institution management system.

Upon concluding the accreditation cycle (five years), the management systems certification institutions shall, 4 (four) months prior to the end of the accreditation cycle, submit completed Form F.003 – Application, including Annex 7 thereto (Scope of Accreditation) to LATAK, in order to carry out the reassessment process.

Prior to implementation of the process of re-accreditation, the Institution shall, in addition to the documents mentioned above, submit documents necessary for implementation of the assessment process, which are the same as asked before a surveillance visit.

More detailed procedure of submission and examination of documents is specified in LATAK-D.008 document "Accreditation procedures", which is available on the website of LATAK www.latak.gov.lv.

IV Assessment and accreditation procedure of the certification institutions

According to Rules No. 754 paragraph 10, LATAK concludes the contract and starts the evaluation process of the certification institution after receiving all the necessary documents.

After receiving all the necessary documents and payment for the relevant evaluation procedure according to the contract, LATAK starts the evaluation process of the certification institution. The initial assessment assesses the compliance of the management systems certification institution with the requirements of the Standard and the documents set by the applicable international and European accreditation organizations, the compliance of the regulatory sphere with the Standard and the relevant regulatory requirements of the relevant field at the location/s of the certification institution (on-site visit). Initial assessment of the certification institution



also includes evaluation of the certification activity (witness audit) in accordance with the requirements of the specific practical certification scheme.

After the assessment of the Institution, an accreditation decision is made in accordance with Rules No. 754, point 19 and document LATAK-D.008 "Accreditation Procedures" for the procedure.

V Surveillance procedure and decision-making of the certification institutions

For the surveillance process of the accredited management system certification institutions, in accordance with Rules No. 754 For point 12, an evaluation program of the certification institution is developed for the entire accreditation cycle (form F.057 – evaluation of practical activity; form F.047 – evaluation of the management system). As part of the accreditation cycle, LATAK evaluates the compliance of the certification institution with the requirements of the Standard or the regulated sphere, the Standard and the field-specific regulatory framework in all accreditation scope.

Within the framework of the accreditation cycle, the compliance of the management system certification institution's practical activities with the requirements of the Standard, in the regulated sphere, compliance with the Standard and the specific regulatory framework of the field is evaluated. Surveillance evaluations are carried out once every 12 (twelve) months. The periodicity of monitoring of accredited certification bodies can be extended up to 18 (eighteen) months, based on the performed risk assessment.

The procedure for making a decision on the results of the certification institutions surveillance is defined in the document LATAK-D.008 "Accreditation procedures", available at www.latak.gov.lv.

VI Performance Witnessing Policy

During the initial assessment, the certification institution shall be able to demonstrate to the LATAK assessment team the performed certification activities applied for accreditation. The LATAK policy for performance demonstration is established in the document LATAK D.019. For individual certification schemes, e.g., ISO 22000, the certification body shall demonstrate the stage 1 and stage 2 audit. LATAK develops a practical action demonstration plan (form F.057) for each management systems certification institution, the execution of which is carried out in accordance with the requirements of IAF MD17 and/or other IAF documents and standards.

VII Status of a Notified Body

If the certification institution applies for the status of a notified body or already operates as a notified body, LATAK shall evaluate its compliance with the field-specific regulatory requirements and the requirements laid down in the document EA-2/17 M:2020.

VIII Exchange of Information

The accredited certification institution shall, by 31 January each year, submit to LATAK the information on the certified management systems and activities of the certification institution, completing the Form F.069 – Management systems certification bodies questionnaire (available

on the LATAK website). This information shall be used to plan the activities for the surveillance of the certification institution.
